Export of Objects of Cultural Interest 2020-21

Report to Parliament pursuant to Section 10 (1) (a) of the Export Control Act 2002 by the Secretary of State for Digital, Culture, Media and Sport covering the period 1 May 2021 to 30 April 2022

The Reviewing Committee on the Export of Works of Art and Objects of Cultural Interest

The Export Control Act 2002 requires the Secretary of State for Digital, Culture, Media and Sport to lay a report on the operation during the year of the Export Control Order relating to the export of objects of cultural interest; and a report on other matters relating to the operation of the Act.

This report covers the reporting requirements of s.10 of the Export Control Act 2002. Separate to this, the Reviewing Committee publishes an annual report on its activity, ensuring the transparency and accountability of a public body.

The Committee met remotely 8 times and in person twice during the 2021-22 reporting period and considered 18 objects referred to it at 9 of those meetings. The Committee will be reporting on 19 objects, one of them from the 2018/19 reporting period. For all but two of these the Committee recommended that their export licences should be deferred. Two were withdrawn, one before it was referred to the Minister for Arts and Heritage, the other one later and the Minister accepted the Committee's recommendation that 15 cases were national treasures and they were deferred. Their aggregate value came to £113,829,831.

To date 3 of them have been saved for the nation:

Case 1 Gould's Original Drawings, Vols I and II

Case 3 The Nativity, by Baldassare Tommaso Peruzzi

Case 13 17th-century manuscript of Italian and French lute music

Three are still under deferral and the other 9 were or can be exported.
