JUDGMENT

1. The respondent has failed to comply with a requirement of section 188 of the Trade Union and Labour Relations (Consolidation) Act 1992. The claim for a protective award succeeds.

The Tribunal makes a protective award in respect of the claimants, all of whom were employed at one establishment at Anson Road, Norwich NR6 6ED, that the employer pay remuneration for the protected period which begins on 26 April 2022 and is for period of 90 days. The recoupment provisions apply.
