Converter Academy Orders

Points discussed in relation to school conversion.

Project: This is a proposal for Beverley St Nicholas Community Primary School, East Riding of Yorkshire, to convert and join Edukos Trust

AB discussion:

- The school is Ofsted good (2014) and has chosen to join Edukos Trust after exploring Multi Academy Trust option. The trust has been working with the school since 2022.
- The Board discussed the trust's plans in relation to current and projected future pupil numbers
- The Board considered the Trust's financial forecasts in light of current pressures on budgets and a School Resource Management Advisor (SRMA) was recommended.
- The governance structure was discussed, and an External Review of Governance was also recommended.
- It was considered that the school would add capacity to and strengthen the Trust.

RD decision: Approve with conditions

Further actions required: External Review of Governance to be commissioned. SRMA to be deployed to the Trust on conversion. Project Lead to inform school/trust of decision

AB discussion:

- The school and trust have a strong working relationship, which has been fostered over a long period of time.

- Geographically a good fit, and along with Scawsby Saltersgate Junior School, would strengthen and add capacity to the Trust

- The school is on an improving trajectory, having been rated Outstanding by Ofsted at its most recent inspection in 2015.
- Geographically a good fit, and along with Town Field Primary School, would strengthen and add capacity to the Trust

Project: This is a proposal for Manor Wood Primary School, Leeds, to convert and join Owlcotes Multi Academy Trust.

AB discussion:

- The school is Ofsted outstanding (January 2019), geographically the match makes sense and it was considered that the school would bring additional capacity into the MAT.
- It was considered that the Trust currently has a strong School Improvement capacity.
- It was said that the Local Authority is supportive, and there are no financial concerns

- The trust has been able to evidence rapid improvement at 2 of their 4 schools at their latest inspections – Kirkburton Middle School rated Good in November 2021 and Birdsedge First School rated Good in September 2022.
- There are currently no financial concerns with the trust considered to be in a healthy position.
- The Board recommended that the Trust further develops its School Improvement Plan prior to any application for growth.
- It was considered that approving the trust's application for Sponsor Status is a positive move for the local area.
