PROVISION OF REQUESTED INFORMATION

Thank you for your request for information about Dog imports, which APHA received on 24 August 2022. Your request has been handled under the Freedom of Information Act (FOIA) 2000.

The information you requested and the response is detailed below:

"1. The number of Romanian dogs imported into the UK under The Balai Directive for the years from 2010 until 2021 with figures shown for each year"

APHA do not have access to data prior to 2017 due to our data retention policy. Please also note that the data from 2021 is for dogs entering Great Britain (GB) not the UK.

information that has been input into the Trade Control and Expert System (TRACES) and the Import of Products, Animals, Food and Feed System (IPAFF) system by a third party.

"2. The number of Romanian dogs imported into the UK via the PETS scheme for the years from 2010 until 2021 with figures shown for each year"

The Pet Travel Scheme covers pets entering Great Britain and is based on information provided by checkers employed by approved carriers of pet animals.

Country or origin is not recorded by the carriers for compliant pets so we are unable to provide this information. This information is not held by APHA.

"3. The number of cases of canine brucellois (B.canis) recorded for Romanian dogs having been imported into the UK for 2010 until 2021 with figures shown for each year"

This information is not held by APHA.

Section 16 (Help and advice)

Unfortunately it is not possible to calculate this number as there is no legal requirement for pre or post import testing into the UK for *Brucella canis* and also no requirement for people submitting samples to APHA for testing to inform us of the animals country of origin. So the data is not available. It may also be the case that some testing is done elsewhere other than APHA and we do not have access to that information (although positive results should be reported to us).

Information disclosed in response to this FOI request is releasable to the public.
