For each one, I would like to know the value of the loan at origination and its percentage of the property purchase value, then the value of the loan at the point of repayment, and the percentage increase or decrease between the loan's value at origination and its value at repayment.

For each one, please can you also provide the local authority in which the property the loan was provided to buy was bought.

Please provide the requested information in the form of one spreadsheet

Response

We can confirm that we do hold some of the requested information. We will address each of your questions in turn.

The number of Help to Buy loans that have been repaid at the most recent date you have data for, and details of all the ones that have been repaid. Right to Appeal

If you are not happy with the information that has been provided or the way in which your request has been handled, you may request an internal review. You can request an internal review by writing to Homes England via the details below, quoting the reference number at the top of this letter.

Your request for review must be made in writing, explain why you wish to appeal, and be received within 40 working days of the date of this response. Failure to meet this criteria may lead to your request being refused.

Upon receipt, your request for review will be passed to an independent party not involved in your original request. We aim to issue a response within 20 working days.

You may also complain to the Information Commissioner's Office (ICO) however, the Information Commissioner does usually expect the internal review procedure to be exhausted in the first instance.
