ENVIRONMENT BILL: THE PRINCE OF WALES' CONSENT FOR MEASURES ON CONSERVATION COVENANTS

I am writing on behalf of Rebecca Pow MP, the Parliamentary Undersecretary for the Environment to seek the consent of The Prince of Wales to measures within the Environment Bill. This Bill contains measures on Conservation Covenants which affect the interests of the Crown, the Duchy of Lancaster and the Duchy of Cornwall.

This letter provides a general overview of the purpose of the Bill and explains the intent of the particular areas where we consider that it requires the consent of The Prince of Wales. I also enclose the latest print of the Bill.

Overview of the Bill

The Environment Bill is comprised of two thematic halves. The first provides a legal framework for environmental governance and accountability once the UK leaves the EU. The second half of this Bill makes provision for specific improvement of the environment including measures on: resource and waste efficiency; air; water; nature and biodiversity; and conservation covenants.

Measures requiring consent

I would draw your attention to the following parts of the Bill which I believe require the Prince of Wales' consent.

Part 7 (conservation covenants) of the Bill applies to Crown land as it applies to any other land - see Schedule 18. There is no obligation to enter into a conservation covenant, but given that the Schedule deals expressly with the application of the provisions to different kinds of Crown land, we think this will require the consent of the Prince of Wales. There are express references to the Duchy of Cornwall in paragraphs 2 and 3 of the Schedule, but all the provision in paragraph 3 does is identify the "appropriate authority" for the Duchy as for other categories of Crown land.



I should be grateful if you would submit this letter to His Royal Highness with the Minister's recommendation that at the appropriate stage in the proceedings in Parliament a Privy Counsellor may signify Prince's consent to the Environment Bill.

We are proposing to introduce the Bill early in January. I would therefore be grateful if you could respond by 6 January 2020. Should there be any changes to the Bill between now and its introduction, we will of course provide you with an updated Bill print for your consideration; at this stage we do not, however, anticipate that there will be any changes requiring Prince's consent.
