Thank you for your email of 18 July 2022, requesting the following information:

Further to your query, the release certificate that I enquired about is the MOD form 654.

This has been lost since the vehicle was sold but apparently it is required to register the vehicle with DVLA.

Your request has been handled in accordance with the Freedom of Information (FOI) Act 2000. A Date In Service Certificate (DISC) for your vehicle is attached to this response at Annex A. The DISC is the direct replacement for the MOD Form 654 and is used for the same purpose.
