Non-Technical Summary

This Noise and Vibration Monitoring Report fulfils HS2 Limited's commitment detailed in the Environmental Minimum Requirements (EMRs), Annex 1, Code of Construction Practice, to present the results of noise and vibration monitoring carried out within the London Borough of Camden during the month of October 2022.

Within this period monitoring was undertaken at the following worksites:

- Noise monitoring was undertaken in the vicinity of The Adelaide Road Ventilation Shaft (ref.: ARVS) where construction of working platform, foundation works, extension of concrete crane base, power site connection works, concrete breaking out, excavation works, sheet piling works, site drainage installations, removal of vegetations and concrete blocks from site, handrail works and removal of working platform were underway.
- Noise monitoring was undertaken in the vicinity of the Vehicle Holding Area worksite (ref.: VHA), where compound operations were underway.
- Noise monitoring was undertaken in the vicinity of Euston Throat Retained Cut and Granby Terrace Bridge worksite (ref.: ETRC & GTB) where piling, excavation works and installation of supports, reinforced concrete works, welfare and site services maintenance and utility diversion works were underway.
- Noise monitoring was undertaken in the vicinity of Euston Scissor Cut worksite (ref.: ESC) where site maintenance, site mobilisation and deliveries, surveys, earthworks, haul road and site drainage, installation and maintenance of site temporary services, scaffolding works, piling, retaining wall works and water treatment works were underway.
- Noise and vibration monitoring were undertaken in the vicinity of the Hampstead Road Bridge worksite (ref.: HRB) where sewer diversion works, traffic management works, hoarding works, road junction improvements and utility works were underway.
- Noise and vibration monitoring were undertaken in the vicinity of the Euston Cavern worksite (ref.: ECAV) where reinforced concrete works, mitigation works, surveys, tunnelling works, utilities diversions, groundwater and gas monitoring and sewer lining were underway.
- Noise monitoring was undertaken in the vicinity of On-Network worksites (ref.: B, C, D, E, F, G and H), where work activities included:
 - Non-intrusive surveys and signal hood installation (worksite G).
 - Content management system works, non-intrusive surveys and scaffold works (worksite H).

- o No HS2 works were undertaken at worksites B, C, D, E and F.
- Noise monitoring was undertaken in the vicinity of the Former National Temperance Hospital North worksite (ref.: NTH-N) where guide wall works were underway.
- Noise monitoring was undertaken in the vicinity of the Former National Temperance Hospital Euston North worksite (ref.: NTH-EN) where test piling and power utility works were underway.
- Noise monitoring was undertaken in the vicinity of Maria Fidelis worksite (ref.: MF)
 where cabins installation, installation of temporary power connections, installation
 of pyramid blockwork and excavations were underway.
- Noise monitoring was undertaken in the vicinity of the Euston Towers Demolition worksite (ref.: ETD), where construction of access ramp, installation of precast concrete block and backfilling, material deliveries and lighting installation were underway.
- Noise monitoring was undertaken in the vicinity of the Traction Substation worksite (ref.: TSS) where wall works, tunnelling works, construction of concrete slab and power utility works were underway.
- Noise monitoring was undertaken in the vicinity of the Interim Taxi Rank worksite (ref.: ITR), where piling, guide wall works, attenuation tank excavation, power utility works and heavy machine delivery were underway.

Further works, where monitoring did not take place, were also undertaken at various locations where installation of utility works and compound installation were underway.

The HS2 threshold levels for significant noise impacts, which are defined in Information Paper E23 (https://www.gov.uk/government/publications/hs2-information-papers-environment) were exceeded fifteen (15) times during the reporting period.

There were no exceedances of trigger levels as defined in section 61 consents during the reporting period.

Four (4) complaints were received during the monitoring period. A description of complaints, the results of investigations and any actions taken are detailed in Table 8 of this report.

L _{Aeq,T}	See equivalent continuous sound pressure level
Ambient sound	A description of the all-encompassing sound at a given location and time which will include sound from many sources near and far. Ambient sound can be quantified in terms of the equivalent continuous sound pressure level, $L_{p,eq,T}$
Decibel(s), or dB	Between the quietest audible sound and the loudest tolerable sound there is a million to one ratio in sound pressure (measured in Pascal (Pa)). Because of this wide range, a level scale called the decibel (dB) scale, based on a logarithmic ratio, is used in sound measurement. Audibility of sound covers a range of approximately 0-140dB.
Decibel(s) A- weighted, or dB(A)	The human ear system does not respond uniformly to sound across the detectable frequency range and consequently instrumentation used to measure sound is weighted to represent the performance of the ear. This is known as the 'A weighting' and is written as 'dB(A)'.
Equivalent continuous sound pressure level, or L _{Aeq,T}	An index used internationally for the assessment of environmental sound impacts. It is defined as the notional unchanging level that would, over a given period of time (T), deliver the same sound energy as the actual time-varying sound over the same period. Hence fluctuating sound levels can be described in terms of an equivalent single figure value, typically expressed as a decibel level.
Exclusion of data	Measurement of noise levels can be affected by weather conditions such as prolonged periods of rain, winds speeds higher than 5m/s and snow/ice ground cover. Noise levels measured during these periods are considered not representative of normal noise conditions at the site and, for the purposes of this report, are excluded from the assessment of exceedances and calculation of typical noise levels and are also greyed out in charts. Identifiable incongruous noise and vibration events not attributable to HS2 construction noise are also excluded.
Façade	A facade noise level is the noise level 1m in front of a large reflecting surface. The effect of reflection, is to produce a slightly higher (typically +3 dB) sound level than it would be if the reflecting surface was not there.
Free-field	A free-field noise level is the noise level measured at a location where no reflective surfaces, other than the ground, lies within 3.5 metres of the microphone position.
LOAEL	Lowest Observed Adverse Effect Level - the level above which adverse effects on health and quality of life can be detected.
Peak particle velocity, or PPV	Instantaneous maximum velocity reached by a vibrating element as it oscillates about its rest position. The PPV is a simple indicator of perceptibility and risk of damage to structures due to vibration. It is usually measured in mm/s.
SOAEL	Significant Observed Adverse Effect Level - the level above which significant adverse effects on health and quality of life occur.
Sound pressure level	The parameter by which sound levels are measured in air. It is measured in decibels. The threshold of hearing has been set at 0dB, while the threshold of pain is approximately 120dB. Normal speech is approximately 60dB at a distance of 1 metre and a change of 3dB in a time varying sound signal is commonly regarded as being just detectable. A change of 10dB is subjectively twice, or half, as loud.
Vibration dose value, or VDV	An index used to evaluate human exposure to vibration in buildings. While the PPV provides information regarding the magnitude of single vibration events, the VDV provides a measure of the total vibration experienced over a specified period of time (typically 16h daytime and 8h night-time). It takes into account the magnitude, the number and the duration of vibration events and can be used to quantify exposure to continuous, impulsive, occasional and intermittent vibration. The vibration dose value is measured in m/s ^{1.75} .

1 Introduction

- 1.1.1 HS2 is required to undertake noise (and vibration) monitoring as necessary to comply with the requirements of the High Speed Rail (London-West Midlands) Environmental Minimum Requirements, including specifically Annex 1: Code of Construction Practice, in addition to any monitoring requirements arising from conditions imposed through consents under Section 61 of the Control of Pollution Act, 1974 or through Undertakings & Assurances given to third parties. Such monitoring may be undertaken for the following purposes:
 - monitoring the impact of construction works;
 - to investigate complaints, incidents and exceedance of trigger levels; or
 - monitoring the effectiveness of noise and vibration control measures.

Monitoring data and interpretive reports are to be provided to each relevant local authority on a monthly basis and shall include a summary of the construction activities occurring, the data recorded over the monitoring period, any complaints received, any periods in exceedance of agreed trigger levels, the results of any investigations and any actions taken or mitigation measures implemented. This report provides noise data, and interpretation thereof, for monitoring carried out by HS2 within the London Borough of Camden (LBC) for the period 1st to 31st October 2022.

- 1.1.2 Active construction sites in the local authority area where monitoring was undertaken during this period include:
 - The Adelaide Road ventilation shaft ref.: ARVS, (see plan 2 in Appendix A), where work activities included:
 - Working platform construction, including vacuum excavations and reinforced concrete works.
 - Foundation works.
 - Extension of concrete crane base.
 - Site power connections.
 - Concrete breaking out.
 - o Excavations.
 - o Sheet piling works, including installation of anchors and forming holes.
 - Site drainage installation.
 - Removal of vegetations and concrete blocks from site.

- Handrail works
- Installation of throughs and cabling works.
- Removal of working platforms.
- Vehicle Holding Area worksite ref.: VHA (see plan 1 in Appendix A), where work activities included:
 - o General compound operation and installation of tank.
- Euston Throat Retained Cut and Granby Terrace Bridge worksite ref.: ETRC & GTB (see plan 2 in Appendix A), where work activities included:
 - Piling (including pile mat preparation).
 - Excavating and propping.
 - o Reinforced concrete works.
 - Welfare and site services maintenance, including tank installation.
 - Utility diversion works.
- Euston Scissor Cut worksite ref.: ESC (see plan 2 in Appendix A), where work activities included:
 - Site maintenance.
 - Site mobilisation and deliveries.
 - Sitewide surveys and ground investigation (including unexploded ordinance survey probing).
 - Earthworks.
 - Haul road and site drainage.
 - Installation and maintenance of site temporary services.
 - Scaffolding.
 - Sheet and bored piling.
 - Retaining wall works (including hanging bar trials and mitigation slabs).
 - Water treatment works, including sewer lining and site drainage installation.
- Hampstead Road Bridge worksite ref.: HRB (see plan 3 in Appendix A), where work activities included:
 - Sewer diversion works.
 - Traffic management.
 - Hoarding works.
 - Road junction improvement works.

- Euston Cavern worksite ref.: ECAV (see plan 3 in Appendix A), where work activities included:
 - o Reinforced concrete works.
 - Mitigation works.
 - Intrusive surveys at road level.
 - Tunnelling works.
 - Utility diversions.

 - Sewer lining.
- On-Network worksites ref.: B, C, D, E, F, G and H (see plan 3 in Appendix A),
 where work activities included:

 - Installation of temporary site power connections.
 - Installation of pyramid blockwork.
 - o Excavations.
- Euston Towers Demolition worksite ref.: ETD (see plan 4 in Appendix A), where work activities included:
 - Construction of new ramp access, including removal of concrete barrier.
 - o Installation of precast concrete block and backfilling.

- Material deliveries.
- Lighting installation, including canopy lighting installation.
- Traction Substation worksite ref.: TSS (see plan 4 in Appendix A), where work activities included:
 - o Wall work, including installation of lift liner walls.
 - Tunnelling work.
 - Construction of concrete slab, including slab soffit decking and rebar installation.
 - Power utility works.
- Interim Taxi Rank worksite ref.: ITR (see plan 4 in Appendix A), where work activities included:
 - Test piling.
 - Guide wall construction.
 - Power utility works.
 - Attenuation tank excavation, including backfilling and pipework.
 - Heavy machine deliveries.
- 1.1.3 Further works, where monitoring did not take place, were also undertaken at various locations where installation of utility works and compound installation were underway.
- 1.1.4 The applicable standards, guidance, and monitoring methodology are outlined in the construction noise and vibration monitoring methodology report which can be found at the following location

1.2 Measurement Locations

- 1.2.1 Thirty-four (34) noise and eleven (11) vibration monitoring installations were active across eighteen worksites in October in the LBC area. Table 2 summarises the position of noise and vibration monitoring installations within the LBC area in October 2022.
- 1.2.2 Noise monitor in Clarkson Row (ref.:CR) was still off-power during October following the power outage in September. Liaison was made with the local borough council to investigate the cause and the power to the monitoring station is being recovered.

1.2.3 Maps showing the position of noise and vibration monitoring installations are presented in Appendix B.

2 Summary of Results

2.1 Summary of Measured Noise and Vibration Levels

2.1.3 Appendix C presents graphs of the noise and vibration monitoring data over the month for each of the measurement locations. Noise data presented consists of the hourly L_{Aeq} values and, where relevant, the L_{Aeq,T} values (where the time period T has been taken to be the averaging period as specified in Table 1 of HS2 Information Paper E23). Vibration data presented consist of hourly PPV values. 2.2 Exceedances of the SOAEL

2.2.1 The significant observed adverse effect level (SOAEL) is defined in the 'Planning Practice Guidance – Noise' as the level above which "noise causes a material change in behaviour and/or attitude, e.g. avoiding certain activities during periods of intrusion; where there is no alternative ventilation, having to keep windows closed most of the time because of the noise. Potential for sleep disturbance resulting in difficulty in getting to sleep, premature awakening and difficulty in getting back to sleep. Quality of life diminished due to change in acoustic character of the area."

- 2.2.2 HS2 Phase One Information Paper E23: Control of Construction Noise and Vibration sets out the SOAELs for construction noise.
- 2.2.3 Where reported construction noise levels exceed the SOAEL at nearby receptors, relevant periods will be identified. Summary statistics to evaluate ongoing qualification for noise insulation and temporary rehousing are also presented where relevant.
- 2.2.4 Table 5 presents a summary of recorded exceedances of the SOAEL at each measurement location over the reporting period, including the number of exceedances during each time period.

2.2.5 For the purpose of assessing eligibility for noise insulation or temporary rehousing, multiple exceedances of the SOAEL in a 24-hour period would be counted as a single exceedance during that day. Over the reporting period, the overall number of SOAEL exceedances at each measurement location is shown in Table 6 and may be lower than the total sum of individual exceedances reported in Table 5 for each location.

- 2.2.6 Twenty-one (21) SOAEL exceedances were recorded due to HS2 construction works during October 2022. One (1) exceedance occurred at monitoring locations N024 and N019, two (2) at monitoring location N026a, three (3) at monitoring location N014 and eight (8) at monitoring location N045. All SOAEL exceedances occurred during normal weekday working hours.
- 2.2.7 Exceedances of the SOEAL at N045 did not meet the temporal criteria contained within HS2 information paper E23 for triggering noise insulation eligibility, whereby the SOAEL must be exceeded for at least 10 days during any 15 day period.

2.3 Exceedances of Trigger Level

2.3.1 Table 7 provides a summary of exceedances of the S61 trigger noise levels determined to be due to HS2 related construction noise measured during the reporting period, along with the findings of any investigation.
