Please provide the dates in the 2021 calendar year when land – owned by the Ministry of Defence – from "the wire" at the south of the firing range at Middlewick, Colchester, as far as Weir Lane was used for training purposes for military personnel.

If this is of assistance, I am assured by local residents that the answers are "none" but I need to have this confirmed officially."

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).
