Which of these sites has been submitted to the council as available for development in the next 10 years"?

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

A search for the information has now been completed within the Ministry of Defence (MOD) and I can confirm that all the information in scope of your request is held and can be found below.

Please can you confirm which of the sites 2069, 2070, 2071, 2076, 2077, 2073, 2074, 2075 are owned by the DIO? Map below.

All the sites listed above are owned by the Ministry of Defence (MOD).

Which of these sites if not owned by the DIO are used or leased by the DIO?

All the sites are owned by the MOD.

Which of these sites has been submitted to the council as available for development in the next 10 years?

The Defence Infrastructure Organisation, on behalf of the Secretary of Defence, wrote to Wiltshire Council on 9 March 2021 advising that further assessment of Site 2075, for residential development, is being supported by MOD.

Under Section 16 of the Act (Advice and Assistance) you may find it helpful to know that further assessment of Site 2075 'Land South of the Railway Line' is supported by the MOD, subject to there being no access through the MOD estate to the north of the railway line.
