Thank you for your email of 18 August 2022 to the Ministry of Defence (MOD), seeking information about numbers of MOD Civilian personnel and Trade Union membership.

You requested the following information:

"Q1. What is the strength of the Ministry of Defence Civil Service (MOD CS)?

Q2. I wonder if you are able to provide the figures of MOD CS who are members of the trade unions, broken down by union if possible?

PCS Prospect FDA GMB Unite″

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

A search for the information has now been completed within the MOD and I can confirm that some information in scope of your request is held.

I can confirm information is held to answer your first question but is withheld under Section 21 of the FOIA (Information accessible by other means).

Section 21 of the FOIA is an absolute exemption therefore we do not have to consider whether or not it would be in the public interest to provide the information. However, under Section 16 of the FOIA the requested information can be found at the link below;

No information in scope of your second question is held. This is because Trade Union (TU) subscriptions are no longer deducted through the MOD payroll. When subscriptions were taken from pay reasonably accurate membership figures could be estimated based on those deductions, although there was no visibility of individuals who had chosen to pay membership through direct debits or other means. However, once MOD stopped collecting TU subscriptions, there was no longer any means of identifying TU members.
