Thank you for your email of 23 September 2022, requesting the following information:

'I would like to know the rotorcraft performance parameters specified in the £60M. R&D contract, awarded by DE&S to Leonardo Helicopters this year to design and manufacture a Proteus UAS prototype under RWUAS Capability Concept Demonstration (CCD): specifically endurance, range, payload, speed, MTOW, maximum dimensions, and cost-ceiling for production aircraft. Any take-off, cruise, and landing noise limitations too.

It is believed much of the rotorcraft transport capability can be - will be - provided more costeffectively in the future by hydrogen-powered ultra-short-STOL aircraft and that the U.K. should be actively supporting this to deliver maximum value to the taxpayer.'

Your request has been handled in accordance with the Freedom of Information (FOI) Act 2000.

A search for the information has now been completed within the Ministry of Defence (MOD), and I can confirm that some information in scope of your request is held.

No performance parameters are explicitly specified in the Research & Development contract for a Proteus UAS prototype. The primary driving outcome is to understand the viability of a new class of air vehicle and provide evidence generating experiments and demonstrations necessary to support the anticipated 2025 Integrated Review and other MOD decisions. Individual performance parameters will be established within any future programme to address this desire and will be judged as a whole at that point.

In relation to future rotorcraft transport capability, Proteus will consider the technology status and potential growth options regarding all current and potential fuel types and their associated propulsion systems to ensure best system capability and value outcomes for MOD customers, UK Industry and the taxpayer.
