FREEDOM OF INFORMATION ACT 2000: MINISTRY OF DEFENCE POLICE: HOW FOI REQUESTS ARE DEALT WITH.

We refer to your clarifying email dated 25th July 2022 to the Ministry of Defence Police which was acknowledged on the same date.

We are treating your email as a request for information in accordance with the Freedom of Information Act 2000 (FOIA 2000).

In your email you requested the following information:

a disclosure Log what are the criteria for disclosure of Freedom of Information Act requests online on the force website on the internet.

A search for information has now been completed by the Ministry of Defence Police and I can confirm that we do hold information in scope of your request.

For clarity, you have submitted a request to the Ministry of Defence Police (MDP), therefore I have assumed that the intention of your request is to capture only information held by MDP.

- 5. How many people are employed by your Police force to process and deal with Freedom of Information Act requests? what is the annual cost to the force in processing Freedom of Information Act requests?

There are 3 members of the Freedom of Information (FOI) team within the Ministry of Defence Police.

The total pay costs are approximately £121,631 per annum inclusive of National Insurance and Pension payments.

While there is the cost of staffing the FOI team this doesn't take into account the cost it takes departments to provide their responses, and in some cases this can take some time as the information is quite difficult to locate.
