FREEDOM OF INFORMATION ACT 2000: MINISTRY OF DEFENCE POLICE: JOB OFFER FOR POTENTIAL RECRUIT.

We refer to your email dated 12th August 2022 to the Ministry of Defence Police which was acknowledged on 15th August 2022.

We are treating your email as a request for information in accordance with the Freedom of Information Act 2000 (FOIA 2000).

In your email you requested the following information:

Please send me the following information by email.

- **What is the time between sending a job offer to a potential recruit to the Ministry of Defence Police and the start of their training course?**
- **On what date was the first job offer made to a person on the recruit training programme which started on 09/05/2022?**

A search for information has now been completed and I can confirm that we do hold information in scope of your request.

- **What is the time between sending a job offer to a potential recruit to the Ministry of Defence Police and the start of their training course?**

Job offers are sent to potential recruits no less than 8 weeks before the course start date.

- **On what date was the first job offer made to a person on the recruit training programme which started on 09/05/2022?**

No information is held for this question but under Section 16 of the Freedom of Information act (advice & assistance), I can tell you that Statement of Particulars started to be issued to potential recruits from around the 9th February 2022 for the training starting on the 9th May 2022.
