We are treating your email as a request for information in accordance with the Freedom of Information Act 2000 (FOIA 2000).

- 3. State whether you intend to continue your membership of any Stonewall scheme in the future, and if so which.

We are withholding the Workplace Equality Index (WEI) Feedback form, received from Stonewall for 2019/20, under Section 41 of the FOIA (Information provided in confidence).

We have considered the Commissioner's guidance on the Section 41 exemption and we are satisfied that all criteria can be met. Feedback was provided to the MDP from a third party organisation, Stonewall, whose terms and conditions of membership explicitly state that information provided by them is confidential. Although disclosure would provide transparency, breaching our duty of confidence would have a commercial impact on Stonewall, which would be actionable.

We acknowledge the Decision Notices against the University of Oxford (IC-129040-Y4T2) and the University of Huddersfield (IC-125081-Q8J6). However, we refer you to the Decision Notice for Cheshire East Council (IC-98477-S4V6) which supports the application of Section 41 FOIA, for withholding the WEI Feedback form.

Under Section 16 (advice and assistance) of the FOIA you may wish to rephrase your questions and resubmit them, to avoid asking for information that is given to the MOD in confidence.

If you wish to complain about the handling of your request, or the content of this response, you can request an independent internal review by contacting the Information Rights Compliance team, Ground Floor, MOD Main Building, Whitehall, SW1A 2HB (e-mail CIO-FOI-IR@mod.gov.uk).

Please note that any request for an internal review should be made within 40 working days of the date of this response.
