Thank you for your email of 17 October 2022 to the Ministry of Defence (MOD), seeking information about Annual Allowance Pensions savings statement

You requested the following information:

" Under the Freedom of Information Act 2000, please could you provide me the following related to Annual Allowance Pensions Savings Statements:

In FY21/22 and FY22/23, how many Service Personnel were sent an Annual Allowance Pensions Savings Statement?

Of the above, what is their rank, service and gender?

Of the above, how many are Medical and Dental Officers?"

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

A search for the information has now been completed within the Ministry of Defence, and I can confirm some of the information you have requested is held. However, I have to advise you that we would not be able to answer your questions without exceeding the appropriate limit.

Section 12 of the FOI Act makes provision for public authorities to refuse requests for information where the cost of dealing with them would exceed the appropriate limit, which for central government is set at £600. This represents the estimated cost of one person spending 3.5 working days in determining whether the department holds the information, locating it, retrieving it and extracting it.

In order to fully answer your question, to seek the Rank, Service, Gender and if they are a Medical and Dental officer, would require locating, manually calling and interrogating 3,745 pension files that have had Annual Pensions Statement Issued, taking at least 187 hours. At the rate of £25 per hour, this would far exceed the appropriate cost limit.

Under section 16 (Advice and Assistance), it may be helpful to advise that no Pensions savings statements have been issued for the Financial Year 2022/23, this is because under His Majesty's Revenue and Customs rules, Annual Allowance pensions savings statements must be issued retrospectively by 6 Oct in the year that the tax year ends.
