This is a request for information under the Freedom of Information Act 2000. I would like to request the following information:

- 1. In each year from 2017 to 2021 how much money has been allocated to engagement with the LGBT+ community?
- 2. In each year from 2017 to 2021 how police money has been allocated to engagement with the trans community specifically?

A search for information has now been completed by the Ministry of Defence Police and I can confirm that we do hold information in scope of your request.

1. In each year from 2017 to 2021 how much money has been allocated to engagement with the LGBT+ community?

2016/17 £3,696 - Stonewall membership

2017/18 £3,000 - Stonewall membership

2018/19 £3,000 - Stonewall membership

2019/20 £3,000 – Stonewall membership, £1,076.40, Stonewall Workplace Conference, £5250 – Stonewall Allies Programme

2020/21 £3,000 Stonewall membership £209.40 , Stonewall Workplace Conference Digital Learning Series

2. In each year from 2017 to 2021 how police money has been allocated to engagement with the trans community specifically?
