Thank you for your email of 27 May 2022 requesting the following information:

*"I am writing to request detail on the boundary locations for the land held under freehold, leasehold, or licenced, by the MOD within the Antony Training Area.*

*A low-resolution version of this information can be viewed on page 273 of the publicly available document published in 2007 titled "The Need for Military Training on Defence Training Estate South West (DTE SW)" however it is not possible to see where these boundaries lie relative to any local publicly accessible land and routes. As such I am requesting information on these boundaries be provided either within an electronic vector based format of your choosing (e.g as a shape file or KML), or as fixed copy files at no coarser scale than 1:15,000."*

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

A search for the information has now been completed within the Ministry of Defence (MOD) and I can confirm the information you have requested can be easily accessed via HM Land Registry using the following link: [HM Land Registry - GOV.UK \(www.gov.uk\)](http://www.gov.uk)

Under Section 16 of the FOIA (Advice and Assistance), you may find it helpful to know that there are several permissive rights of way across Tregantle Fort. One path runs from a Council parking area to the beach, and another runs across the front of the fort which is a permissive route of the Southwest Coastal Path. Both are closed to public access when military firing is taking place. Firing notices can be found at: <https://www.gov.uk/government/publications/tregantle-firing-notice> to ensure the public are aware when access is restricted. Local byelaws allow for no firing during certain times of the year including August, and bank holidays. A map showing these permissive rights of way is attached as Annex A.
