Thank you for your email of 5 June 2022 requesting the following information:

*"I am writing to request information regarding Colerne Airfield in Wiltshire adjacent to and forming alongside Azimghur Barracks, near the village of Colerne.* 

My question is specifically regarding the current management of the airfield in regards to making it a managed habitat for Birds, Bees and Butterflies (BBB) as the runways are not currently being open for use.

Please can you tell me:

- 1. The total area that is grassland/field.
- 2. The total area that is managed to promote biodiversity esp habitat for BBB.
- 3. A summary of the site specific action plan to promote biodiversity and esp habitat for BBB."

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

A search for the information has now been completed within the Ministry of Defence (MOD) and I can confirm that information in scope of your request is held.

A1. Part of Colerne Airfield is a designated Local Wildlife Site for the unimproved chalk grassland habitat it supports. There are also some additional grassland areas outside of the Wildlife Site. The total extent of grassland is approximately 122.5 hectares (ha).

A2. All 122.5 ha are managed by a farm tenant under a licence agreement with the MOD that promotes the conservation interest, including birds, bees and butterflies.

A3. There is no specific Conservation Management Plan in place. However, the licence agreement between MOD and the farm tenant requires the tenant to manage the land sympathetically for wildlife to maintain the grasslands botanical interest and the associated fauna, including birds, bees and butterflies. The licence includes the following conditions, which are appropriate for managing a low input traditional hay meadow:

- Shall not mow more than twice a year and must dry and remove grass;
- Shall not apply artificial fertilisers;

• Is permitted to scarify and roll the area.
