National Statistics Publication: Criminal Justice Statistics Quarterly (CJSQ)

The CJSQ publication covers trends in the use of out of court disposals, defendants prosecuted, offenders convicted, remand and sentencing decisions. Each quarterly publication includes the statistical bulletin and overview tables. The annual publication, year ending December, also includes trends in motoring offences and the data tools (see below).

Products published as part of the CJSQ publication

The statistical bulletin

The bulletin is published with each **quarterly** publication, in pdf and html formats, covering the key trends within the Criminal Justice System the most recent year.

- Quarter 1: Year ending March
- Quarter 2: Year ending June
- Quarter 3: Year ending September
- Quarter 4: Year ending December (annual publication)

The bulletin covers the following chapters:

- Out of Court Disposals
- Prosecutions and Convictions
- Remands
- Sentencing
- Motoring (annual only)

Overview tables

The overview tables cover the trends year ending a given quarter for the CJS. "Q" tables are produced for all editions, "A" tables are included in the annual edition only.

- Tables Q1.1 to Q1.4 cover overall trends cross-cutting prosecutions, convictions, sentences, out of court disposals and police charge/recorded crime data.
- Tables Q2.1 and A2.1 cover out of court disposals data relating to PNDs and Cautions.
- Tables Q3.1 to Q3.5 and A3.1 cover prosecutions and convictions.
- Tables Q4.1 to Q4.4 cover remands by police and at Magistrates' and Crown courts.
- Tables Q5.1 to Q5.4 cover sentencing decisions.
- Tables A6.1 and A6.2 cover motoring offences.

Data tools

The **annual** publication includes a set of interactive data tools, allowing more in-depth breakdowns of our published data, including, but not limited to, individual offences, demographics (sex, ethnicity, age) and Police Force Area – see Table 1 in Annex A for details.

- **Outcomes by offence**^{*} data on prosecutions, convictions and sentences on a principal offence basis at all courts, breakdown to individual Home Office offence codes
- **Magistrates' court** similar to the outcomes by offence tool; including the results of proceedings at Magistrates' courts e.g. proceedings discontinued, charge dismissed, committed for trial at Crown Court etc
- **Crown court** similar to the outcomes by offence tool; including the results of defendants appearing at Crown Courts e.g. not tried, acquitted and sentenced etc. Also includes plea at Crown Court

- Remands: Magistrates' Court tool and Remands: Crown Court tool includes remand status at respective court: not remanded, bail and custody (remand status with police can be found as a field in the Remands: Magistrates' Court tool)
- Motoring tool includes motoring offences with filters for type/period of disqualification
- **Out of court disposals** includes Cautions (caution type, where issued and their outcome) and Penalty Notices for Disorder (where issued and their outcome)
- All offence prosecutions and convictions by Home Office offence code tool includes offences on an all offence basis, that is, the total number of offences a defendant is prosecuted for (principle offences plus non-principal offences)

The outcomes by offence, Magistrates' and Crown Court tools were improved in 2021 to allow users to break down statistics more easily. Due to functionality, the time series was reduced to 5 years. Previous years can be found in our previous annual publications.

*Please note that the Outcomes by Offence tool has also been released mid-year as part of the year ending June publication, published November 2022. This is the first iteration of the pivot tool mid-year, thus feedback is welcomed.

Please refer to the footnotes and guidance within each pivot tool for more information.

Offence group classification

The **annual** publication includes the machine-readable offence group classification, allowing users to look up offences and their corresponding Home Office offence codes for use in our data tools.

Highlight row 1 and *Ctrl+Shift+L* to turn filters on within the Excel worksheet. For more specific searches use custom filter.

Experimental statistics – Defendants prosecuted for combination of offences (csv)

The **annual** publication includes our Experimental Statistics, whereby combination of offences for which a defendant has been prosecuted can be viewed. The Experimental Statistics zip file contains a Word document with instructions on how to access and manipulate the CSV contained.

Data behind interactive tools

The data contained within all of the data tools published alongside the **annual** edition can be found in CSV format in the Data behind the interactive tools zip file. These files are in an accessible format that can be used to create pivot tools or enter data into other programs.

We are aware of an issue some users have found when trying to access our data tools using a MacBook. By accessing the CSVs in this folder and looking to your settings, this issue is able to be mitigated and MacBook users can create their own pivot tools.
