Converter Academy Orders

Points discussed in relation to school conversion.

Project: Discussion to consider Trinity All Saints CofE VA Primary, Bradford, to convert and join Collaborative Learning Trust

AB discussion:

- The Trust's financial health, including levels of reserves and projections for future budgets were discussed. Trinity All Saints CofE VA Primary believes joining the Collaborative Learning Trust (CLT) will support and strengthen its position.
- Forecasted pupil numbers were discussed, and it was considered the Trust has planned appropriately.
- CLT has recently began operating in Bradford and currently has 3 other Church of England schools. It was considered CLT has the required expertise and capacity to support their growth. The conversion is supported by the Diocesan Board of Education.
- The Board recommended further separation between trustees and school governors.

Project: Discussion to consider St. Mary's & St. Peter's Catholic Primary School, Bradford, to convert and join Blessed Christopher Wharton Catholic Academy Trust

AB discussion:

- Due to changing demographics of the community the school serves, the Diocese does not feel it is appropriate for the school to join one of their Multi Academy Trusts permanently (as the school has very low numbers of Catholic children on roll). The Board heard the proposal for the school to convert and join Blessed Christopher Wharton Catholic Academy Trust, before submitting a Significant Change Application to de-designate as a faith school and subsequently transfer to Co Op Multi Academy Trust. This proposal has the support of both trusts, the Local Authority, the Diocese and the Catholic Education Service
- Impact on staff and local community was discussed, both were considered to be minimal.
- The Co-Op Multi Academy Trust was considered to be an appropriate match for the school in the long term, with an appropriate school improvement resource and strategy.
- The future de-designation of the school via a Significant Change application and subsequent transfer to the Co-Op Multi Academy Trust were agreed in principle.

Project: Discussion to consider Poppleton Road Primary School, York, to convert and join Pathfinder Multi Academy Trust

AB discussion:

- The school chose to join Pathfinder MAT to allow them to share best practice and be part of a community of schools.
- The Board felt this was a strong school who could add capacity to the Trust.
- The Board considered the Trust's financial forecasts in light of current pressures on budgets and a School Resource Management Advisor (SRMA) was recommended.

Project: Discussion to consider Wilberfoss Church of England Voluntary Controlled Primary School, East Riding of Yorkshire, to convert and join The Education Alliance.

AB discussion:

- There is an existing relationship between the school and the Trust through the East Riding School Improvement Partnership.
- Wilberfoss Church of England Voluntary Controlled Primary School chose to join The Education Alliance as they are closely aligned on ethos and values and are geographically close to provide necessary support and collaboration.
- The Trust was considered to be a good fit for the school.

Project: Discussion to consider The Willows School, Rotherham, to convert and join Nexus Multi Academy Trust.

AB discussion:

• The Willows School was judged to be a Good school at its last Ofsted inspection and is the only Local Authority maintained remaining special school in Rotherham.

- Nexus Multi Academy Trust has a strong track record in similar schools and is based geographically very close to the school.
- There is a long-established working relationship and the school joining the trust is seen as mutually beneficially to both organisations.

Project: Discussion to consider age-range change at Wisewood Community Primary School (Tapton School Academy Trust), Sheffield, to allow delivery of 32 FTE nursery places.

AB discussion:

- The proposal is for the Trust to take on the running of nursery provision which is already established on the school premises.
- It was considered the Trust has sufficient plans to grow numbers of nursery children.
- Appropriate consultation has taken place, with no issues raised.

Trust Change

Points discussed in relation to academies moving to another trust.

Project: Discussion to consider Signhills Infants Academy, North East Lincolnshire, to transfer from Signhills Infant Academy and join The St Lawrence Academies Trust.

AB discussion:

- The school chose to join The St Lawrence Academies Trust as they are closely aligned on ethos and values and are geographically close to provide necessary support and collaboration, and because of their existing working relationship.
- Governance of the Trust was discussed, and the Board recommended that primary expertise should be added to the Trust Board.
- It was noted that the Trust has previously had a School Resource Management Advisor (SRMA) commissioned.
- The transfer has been approved by the Diocesan Board of Education, and it aligns with their strategy.
- There is potential for further growth of the Trust in the locality which will further strengthen The St Lawrence Academies Trust.
