In your email you requested the following information:

**The One Show is researching the number of accidents that involve mopeds/low powered motorcycles with provisional licenses. Please could you answer the following questions, broken down annually:**

**1 - Between 2017-2022, how many road accidents involved a moped/motorcycle of 50CC or less (annually)?**

**Please could you break these answers down by the type of license held e.g., full driving license/provisional license/no license held.**

**2 - Between 2017 - 2022, how many people were injured in accidents involving a moped/motorcycle of 50CC or less (annually)?**

**Please could you break these answers down by the type of license held e.g., full driving license/provisional license/no license held.**

**3 - Between 2017-2022, how many road accidents were there in total (annually)?**

**4 - Between 2017 - 2022, how many road accidents involved personal injury (annually)?**

A search for information has now been completed and I can confirm that we do hold information in scope of your request.

Due a technical fault we cannot retrieve the data requested before August 2021 at present.
