Thank you for your email of 23 December 2022 to the Ministry of Defence (MOD) requesting the following information:

*“Freedom of Information ACT (Immediate REPLY please )*

*Could I please have in return all Dates from 1983 to this present year 23/12/22 on which all applications for war pension were made by MYSELF [REDACTED] along with Notifications of being turned Down for the same !*

*Please include in this Freedom of Information Request copies of the Full REPORT ON Orders which I was Detained for 7 days [REDACTED] ,also a Full Signature of Person/s who formally made the accusation against me ,*

*Also A full Copy of my resignation Letter , again Legally with my Signature , as the copy I formally received was not written by my HAND .*

*Please forward all the ABOVE at your earliest convenience , without Comments Stating we do NOT POSSESS these ANYMORE .”*

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

A search for the information has now been completed within the Ministry of Defence and I can neither confirm nor deny whether the MOD holds the information that you have requested.

The Department is not obliged to confirm or deny whether we hold the information as if held, this would relate to personal information. Section 40(5) of the FOIA provides that there is no duty to confirm or deny whether we hold the information. The fact Section 40(5) of the FOIA has been cited should not be taken as an indication that the information you have requested is, or is not, held by the Department. The terms of this exemption of the FOIA mean that we do not have to consider whether or not it would be in the public interest for us to reveal whether or not the information is held.

Notwithstanding the above, under Section 16 of the FOIA (Advice and Assistance), you do have the right to request access any personal data which may be held by the Department under the Data Protection Act 2018 and as such I have passed your requests to the Department's Subject Access Request (SAR) Team which will contact you in order to establish if any such information exists. They will contact you directly. Further information about submitting a Subject Access Request for personal information to the MOD can be found at the link below:

If you wish to complain about the handling of your request, or the content of this response, you can request an independent internal review by contacting the Information Rights Compliance team, Ground Floor, MOD Main Building, Whitehall, SW1A 2HB (e-mail [CIO-FOI-IR@mod.gov.uk](mailto:CIO-FOI-IR@mod.gov.uk)). Please note that any request for an internal review should be made within 40 working days of the date of this response.

If you remain dissatisfied following an internal review, you may raise your complaint directly to the Information Commissioner under the provisions of Section 50 of the Freedom of Information Act. Please note that the Information Commissioner will not normally investigate your case until the MOD internal review process has been completed.
