Thank you for your email of 1 January 2023 to the Ministry of Defence (MOD), requesting the following information:

"3968405 S/Sgt Eric John Holloway Army Air Corps – F.O.I. Request

4544916 Sgt James George Knights Recce Corps – F.O.I. Request

6921574 Cpl William Walter Gibbs RNF- F.O.I. Request

I am trying find out the full medal entitlement of the above-mentioned soldiers for WW2. They were all killed in action in Europe during WW2"

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

A search for the information has now been completed within the MOD and I can confirm that no information in scope of your request is held.

Under the FOIA a public authority is considered to hold information that is requested if it holds the building blocks required to generate it and no complex judgement is required to produce it. In this case the MOD does not hold a medal card for the named individuals. This is because as part of the Defence Records Management Project, a percentage of archived service files have been transferred to The National Archives. The required files have been transferred as part of the project and the MOD is therefore not able to provide the medal entitlement under the FOIA, as all the building blocks required to generate the information are not held.

Under Section 16 of the FOIA (Advice and Assistance) I can advise that the MOD Medal Office (MODMO) provides a service under which they will obtain the records from The National Archives on your behalf and conduct a Medal Assessment.
