This is **not** the same as solar panels which use energy from the sun to produce electricity. Hydrogen boilers - these work in a similar way to standard gas boilers to heat your home and water, but use hydrogen rather than natural gas as fuel. This technology is not currently available in the UK. Hydrogen-ready boilers - These are designed to use hydrogen in the longer term but are initially constructed to use natural gas to heat your home and water. This technology is not yet available.


