# The General Medical Services Statement of Financial Entitlements (Amendment No.3) Directions 2016

The Secretary of State for Health gives the following directions as to payments to be made under general medical services contracts in exercise of the powers conferred by sections 87, 272(7) and (8) and 273(1) of the National Health Service Act 2006(a).

The Secretary of State for Health has consulted, in accordance with section 87(4) of that Act, with the body appearing to the Secretary of State to be representative of persons to whose remuneration these Directions relate.

#### Citation and commencement

- 1.—(1) These Directions may be cited as the General Medical Services Statement of Financial Entitlements (Amendment No. 3) Directions 2016.
  - (2) They come into force immediately after they are signed but have effect in accordance with sub-paragraphs (3) to (5).
  - (3) Paragraph 4 has effect from 1st July 2016.
  - (4) Paragraph 7 has effect from 1st October 2016.
  - (5) Paragraph 8 has effect from 1st April 2017.

#### Amendment of Section 14C of the General Medical Services Statement of Financial Entitlements Directions 2013

- **2.** In Section 14C of the General Medical Services Statement of Financial Entitlements Directions 2013 (Human Papilloma Virus (HPV) Booster)—
  - (a) for the title, substitute "Human Papilloma Virus (HPV) Completing Doses";
  - (b) in paragraph 1(1), for "Human Papilloma Virus (HPV) Booster" substitute "Human Papilloma Virus (HPV) Completing Doses"; and
  - (c) in each place where it appears, for "HPV Booster" substitute "HPV Completing Doses".

#### Amendment of Section 14.D of the General Medical Services Statement of Financial Entitlements Directions 2013

**3.**In Section 14D of the General Medical Services Statement of Financial Entitlements Directions 2013 (Meningococcal Booster Vaccination) for the title substitute "Meningococcal Completing Doses".

### Amendment of Section 20 of the General Medical Services Statement of Financial Entitlements Directions 2013 from 1st July 2016

- **4.** In section 20 of the General Medical Services Statement of Financial Entitlements Directions 2013(a) (Doctors' Retainer Scheme)—
  - (a) in paragraph 20.2 (payments in respect of sessions undertaken by members of the Scheme), for "£59.18" substitute "£76.92"; and
  - (b) after paragraph 20.5 (payment conditions), insert—

#### "Annual payments

- **20.6.**—(1) The Board must pay to an eligible contractor under its GMS contract an annual lump sum payment under the Doctors' Retainer Scheme in respect of any doctor who—
  - (a) before 1st July 2016, was employed or engaged by the contractor and is, on that date, a member of the Scheme by reason of that employment or engagement; or
  - (b) becomes a member of the Scheme on or after 1st July 2016 in respect of any employment with or engagement by the contractor which commences on or before 31st March 2017.
- (2) For the purposes of this paragraph, an "eligible contractor" is contractor to whom paragraph 20.2 (payments in respect of sessions undertaken by members of the Scheme) applies.
- (3) The payment arrangements in this paragraph apply in respect of the period beginning with 1st July 2016 and ending with 30th June 2019.
- (4) The annual payment is to be calculated by the Board by reference to the number of sessions which a doctor described in paragraph (1)(a) or (b) is contracted to perform for the contractor in each week, up to a maximum of four sessions per week, on the following basis, depending on whether the doctor is contracted to perform an annualised number of sessions, or a number of sessions per week:

- (5) Subject to paragraph (6), the Board must pay to the contractor the annual payments due under this paragraph as follows—
  - (a) in respect of a doctor described in paragraph (1)(a)—
    - (i) by 31st December 2016, in respect of the year ending with 30th June 2017,
    - (ii) on 1st July 2017, in respect of the year ending with 30th June 2018, and
    - (iii) on 1st July 2018, in respect of the year ending with 30th June 2019; and
    - (b) in respect of a doctor described in paragraph (1)(b)—
      - (i) on the date on which that doctor becomes a member of the Doctors' Retainer Scheme, and
      - (ii) on the anniversary of that date in each subsequent year in respect of which the payment is due (with payment calculated on a pro rata basis in respect of the final year ending with 30th June 2019).
- (6) The Board must not pay an annual payment in respect of any doctor where an eligible contractor has not provided sufficient information to the Board about the number of sessions per week for which that doctor is employed or engaged by the contractor.
- (7) Where the Board pays an annual payment to an eligible contractor in respect of a doctor, the contractor must pass on the payment to that doctor, net of any applicable deductions payable by that doctor in respect of income tax, national insurance and superannuation contributions, within one calendar month from the date on which the contractor received the payment."

#### Amendment of Chapter 2 of Part 2 of Annex B of the General Medical Services Statement of Financial Entitlements Directions 2013

- **5.** In Chapter 2 of Part 2 of Annex B of the General Medical Services Statement of Financial Entitlements Directions 2013 (Vaccines and Immunisations vaccines and immunisations which are not required for foreign travel), in Table 1—
  - (a) for paragraph (b)(ii) in the right hand column of the second entry relating to Diptheria, Tetanus and Polio, substitute—
  - "(ii) as many doses as required to ensure that a full schedule has been administered at the appropriate intervals as clinically appropriate.";
  - (b) in paragraph (b) in the right hand column of the third entry relating to Hepatitis A, omit "(either two or three)"; and
  - (c) omit the eighth entry in relation to Smallpox.

<sup>(</sup>a) "Annualised sessions" are the number of sessions per week which a performer is contracted to work for a contractor averaged out over the period of a year. They include any sessions which a member of the Doctors' Retainer Scheme is employed or engaged by the contractor to undertake but which that member does not actually undertake because it falls on a statutory holiday or because the member is absent by reason of annual leave or any requirement to undertake continuing professional education.

### Amendment of Chapter 3 of Part 2 of Annex B of the General Medical Services Statement of Financial Entitlements Directions 2013

- **6.** In Chapter 3 of Part 2 of Annex B of the General Medical Services Statement of Financial Entitlements Directions 2013 (Vaccines and Immunisations vaccines and immunisations required for the purposes of foreign travel), in Table 2—
  - (a) for paragraph (c)(ii) in the right hand column of the fourth entry relating to Poliomyelitis, substitute—
  - "(ii) as many doses as required to ensure that a full schedule has been administered at the appropriate intervals as clinically appropriate."; and
  - (b) omit the fifth entry in relation to Smallpox.
