<u>Response</u>

We can confirm that we do hold some of the requested information, which is enclosed with this response as Annex A. Please note that some columns either contain missing data or no data at all, in particular from columns M to S which relates to Equality, Diversity and Inclusion (ED&I) data. We can advise that this is because those database fields are not mandatory for customers to answer therefore where they are blank, customers have opted not to answer. We can further advise that some of those fields are blank if they are sole applications therefore a response for the second applicant is optional.

In relation to the requested Database field "Homes Interested in"

We can inform you that we do hold the information that you have requested. However, we rely on Section 40 (2) of the FOIA to withhold the information from disclosure.

Section 40 – Personal information

We are withholding information on the grounds that in constitutes third party personal data and therefore engages section 40(2) of the FOIA.

To disclose personal data, such as names, contact details, addresses, email addresses and personal opinions could lead to the identification of third parties and would breach one or more of the data protection principles.

Section 40 is an absolute exemption which means that we do not need to consider the public interest in disclosure. Once it is established that the information is personal data of a third party and release would breach one or more of the data protection principles, then the exemption is engaged.

In relation to the requested Database field "Date of application"

We can confirm that Homes England does not hold the information detailed in this part of your request.

To conclude that the information is not held, we have searched with our Agent who holds the information on behalf of Homes England. The Agent has confirmed that this field is not captured in their reporting systems and therefore we are unable to provide this information.

The FOIA does not oblige a public authority to create information to answer a request if the requested information is not held. The duty under section 1(1) is only to provide the recorded information held.

Your request for review must be made in writing, explain why you wish to appeal, and be received within 40 working days of the date of this response. Failure to meet this criteria may lead to your request being refused.

Upon receipt, your request for review will be passed to an independent party not involved in your original request. We aim to issue a response within 20 working days.
