#### IV. Health Information

- I, the undersigned, an authorised Official Veterinarian, certify that table eggs described above meet the following requirements:
- a) Highly pathogenic avian influenza (HPAI) is a notifiable disease in the United Kingdom;
- b) Either
  - \*(i) The UK has been free from HPAI for the past 28 days prior to export, following a stamping out policy in accordance with Article 10.4.6 of the WOAH Terrestrial Animal Health Code;
  - \*(ii) the flock(s) of origin are located outside the 10km surveillance zone(s) around any infected premises in the UK established due to an outbreak of HPAI in poultry according to the definition of the WOAH Terrestrial Code;
- c) the eggs are unfertilized and derived from layer flocks kept on a single farm of origin approved and listed for the import of table eggs by SFA, Singapore;
- d) the eggs are individually marked with a code approved by Defra or the SFA to identify the producing farm;
- e) the farm where the eggs originate from has been tested and found to be free from Salmonella Enteritidis;
- f) no case of velogenic Newcastle disease has been diagnosed on the farm of origin for the last three months prior to export;
- g) The eggs have a fully developed shell and were clean, fresh and fit for human consumption;
- h) The eggs have been handled and packed in appropriately sanitised packaging materials and containers in a hygienic manner;
- j) Additives and/or colouring matters injurious to health have not been added;
