NATIONAL HEALTH SERVICE, ENGLAND

The Alternative Provider Medical Services (Amendment) Directions 2018

The Secretary of State for Health and Social Care, in exercise of the powers conferred by sections 98A, 273(1) and 272(7) and (8) of the National Health Service Act 2006(a), gives the following Directions:

Citation, commencement, application and interpretation

- **1.**—(1) These Directions may be cited as the Alternative Provider Medical Services (Amendment) Directions 2018 and come into force on 1st October 2018.
 - (2) These Directions are given to the National Health Service Commissioning Board(b).
- (3) In these Directions "the principal Directions" means the Alternative Provider Medical Services Directions $2016(\mathbf{c})$.

Amendment of direction 14 of the principal Directions

- **2.** In direction 14 of the principal Directions (mandatory terms for an APMS contract under which essential services are to be provided), in paragraph (1)—
 - (a) for sub-paragraph (f), substitute—
 - "(f) regulations 64 and 64A (patient access to online services);";
 - (b) for sub-paragraph (m) substitute—
 - "(m) Schedule 2, paragraph 16 (patients aged 75 and over: accountable GP) and paragraph 16A (NHS e-Referral Service);"; and
 - (c) for sub-paragraph (o) substitute—
 - "(o) Schedule 2, paragraph 21 (patient preference of practitioner) and paragraph 24 (removal from the list of patients who are violent);".

Amendment of direction 15 of the of the principal Directions

3. In direction 15 of the principal Directions (mandatory terms for an APMS contract under which out of hours services are to be provided), in paragraph 1(a), for "the document entitled "National Quality Requirements in the Delivery of Out of Hours Services" published on 20th July
