Thank you for your email of 10 August 2022 requesting the following information:

"Please can you provide, or signpost me to where I can find the following information;

- 1) city in England with largest number of veterans?
- 2) number of veterans residing in Manchester?
- 3) number of veterans residing in New Zealand? And Auckland City region."

I am treating your correspondence as a request for information under the Freedom of Information Act (FOIA) 2000. A search for the information has been completed within the Ministry of Defence and I can confirm that no information in scope of your request is held by the Department. Under Section 16 (Advice & Assistance) of the Act, you may find it useful to know the information that is already available in the public domain.

Defence Statistics Health publishes an annual bulletin on the location of armed forces pension and compensation recipients using postcode data from the Armed Forces Compensation Scheme, War Pension Scheme and Armed Forces Pension Scheme. Table 3 of the Supplementary Tables includes a breakdown of recipients who are veterans by UK local authorities and metropolitan areas.

Table 2 contains a breakdown of recipients who are veterans by country, however we do not currently publish local level data for recipients located overseas.

Please note, information is only available on individuals who are in receipt of an Armed Forces pension and/or compensation and will therefore not be representative of all veterans in a given location. This information is also reliant on accurate postcode details being voluntarily supplied and updated by those in receipt of a pension and/or compensation.

The latest iteration was published on Thursday 25th August. For the first time, the Census 2021 included a question asking respondents about their status as a veteran of the UK armed forces. The Office for National Statistics and the Office for Veterans Affairs are predicted to publish the data in late 2023 which will provide the most up-to-date and comprehensive breakdown available.
