PROVISION OF REQUESTED INFORMATION

Thank you for your request for information about Poultry statistics, which the Animal and Plant Health Agency (APHA) received on 21 November 2022. Your request has been handled under the Freedom of Information Act (FOIA) 2000.

The information you requested and the response is detailed below:

"I am a veterinary student at the University of Cambridge and am currently writing a dissertation on avian influenza, and how incursions into poultry farms can be prevented. Would it at all be possible for me to have access to the poultry register to look at the size and distribution of poultry farms across the country?

Or are there any other similar datasets you could direct me to?"

Clarity was requested:

"I would like to request the following data:

- Species
- Usual stock numbers
- Access to open air
- Near body of water
- Map reference
- Location ID

I would like this to be UK-wide data and as recent as possible (2022)."

APHA is an Executive Agency of the Department for Environment, Food and Rural Affairs and also works on behalf of the Scottish Government, Welsh Government and Food Standards Agency to safeguard animal and plant health for the benefit of people, the environment and the economy.

For your information the Poultry Register has not been in existence since 2014 when the Animal and Plant Health Agency (APHA) was formed.

The information provided is current at the time of this response.

It is only compulsory to register flocks of poultry of over 50 birds with APHA. Owners/Keepers can voluntarily register flocks of less than 50 birds. To find out more about the registration of birds visit the GOV.Uk website for information here: https://www.gov.uk/government/publications/poultry-including-game-birds-registration-rules-and-forms

The information provided are the livestock numbers provided by the keeper upon registration. As part of the registration process, APHA ask the keeper what their usual stock numbers are, and this is recorded in the APHA database. It is the responsibility of the owner/keeper to keep APHA informed of any number changes.

Any blank entries for livestock numbers or those with 0 is because there was no stock to record at the time of registration and APHA have not been informed since of any changes by the owner/keeper.

Where the post code is described as blank the post code of the premises was not recorded at the time of registration.

Unfortunately, some of the information you have requested, Location ID and Map reference and part of the postcode have been exempted from release citing Section 40 of the Freedom of Information Act (FOIA) 2000.

Section 40

We can confirm that this information could lead to the identification of premises. Section 40(2), read in conjunction with 40(3)(a)(i), of the FOIA provides that personal data relating to third parties is exempt information if disclosure would breach the Data Protection Act 2018 (DPA).

APHA is an Executive Agency of the Department for Environment, Food and Rural Affairs and also works on behalf of the Scottish Government, Welsh Government and Food Standards Agency to safeguard animal and plant health for the benefit of people, the environment and the economy.

This information if released still engages the exemption because the personal data relates to others who would, or would likely, be identified or identifiable from that information.

APHA consider that disclosure of this information is likely to breach the first data protection principle in Schedule 1 of the DPA, which relates to the fair and lawful processing of personal data, in two ways. First, disclosure would not constitute 'fair' processing of the personal data, second, disclosure would not satisfy any of the conditions for data processing set out in Schedule 2 to the DPA.

Therefore, we have concluded that this information is exempt from disclosure under section 40 of the FOIA.

Information disclosed in response to this FOI request is releasable to the public. In keeping with the spirit and effect of the FOI and the government's Transparency Agenda, this letter and the information disclosed to you may be placed on GOV.UK, together with any related information that will provide a key to its wider context. No information identifying you will be placed on the GOV.UK website.
