Thank you for your email of 10 January 2023 to the Ministry of Defence (MOD) requesting the following information about Continuance the West Midlands Veterans Advisory Pensions Committee:

"I am the CEO of a charity that gives grants to service and ex-service families for their children where their education has been compromised or put at risk as a result of their parent's service.

Over 25% of our applications are related to Continuity of Education allowance (CEA) mainly the loss of it due to changes in circumstance, a child moving to 6th form, leaving the forces etc and thus a significant proportion of the grants we give go towards independent / state boarding fees.

The trustees have tasked me with finding out:

- 1. how many serving personnel are currently in receipt of CEA
- 2. breakdown of CEA receipients by rank and service
- 3. Breakdown of CEA by key- stage of education or at the very least prep/ secondary.
- 4. breakdown between independent and state boarding

I am therefore submitting a Freedom of Information request for this information.

The information would only be used internally to help ensure we are able to find the families most in need of our grants".

In your further email received on 7 February 2023 you clarified details of the request, stating:

"Data for Spring 2022 for question 4 would be find thank you. Would you be able to separate out numbers for the different schools or do you not have this information?"

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

A search for the information has now been completed within the MOD and I can confirm all information in scope of your request is held.
