Thank you for your email of 6 February 2023 to the Ministry of Defence (MOD), seeking information about reasonable expenses.

You requested the following information:

"I wish to request a FOI on the following:

The Veterans UK sent me to a Specialist back in Jan/Feb 2002, for my medical Condition Perineum. When I travelled I was given Reasonable Expenses, I believe this included Flights, Accommodation, Public Transport, Loss of Earnings, Taxis, Food Costs for each meal and a daily Rate for ancillary items/expenses!!!

I would like all relevant documents that have anything to do with this subject item??? In-particular my claim for these reasonable Expenses and what the Veterans UK actually gave me as reasonable expenses and any other relating documents!!!!!"

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

A search for the information has now been completed within the Ministry of Defence and I can neither confirm nor deny whether the MOD holds the information that you have requested.

The Department is not obliged to confirm or deny whether we hold the information, as if held this would relate to personal information. Section 40(5) of the FOIA provides that there is no duty to confirm or deny whether we hold the information. The fact Section 40(5) of the FOIA has been cited should not be taken as an indication that the information you have requested is, or is not, held by the Department. The terms of this exemption of the FOIA mean that we do not have to consider whether or not it would be in the public interest for us to reveal whether or not the information is held.

Notwithstanding the above, under Section 16 of the FOIA (Advice and Assistance), you do have the right to request access any personal data which may be held by the Department under the Data Protection Act 2018 and as such I have passed your requests to the Department's Subject Access Request (SAR) Team which will contact you in order to establish if any such information exists. If you wish to complain about the handling of your request, or the content of this response, you can request an independent internal review by contacting the Information Rights Compliance team, Ground Floor, MOD Main Building, Whitehall, SW1A 2HB (e-mail CIO-FOI-IR@mod.gov.uk). Please note that any request for an internal review should be made within 40 working days of the date of this response.

If you remain dissatisfied following an internal review, you may raise your complaint directly to the Information Commissioner under the provisions of Section 50 of the Freedom of Information Act. Please note that the Information Commissioner will not normally investigate your case until the MOD internal review process has been completed.
