# **Description of change**

Due to School Census queries received the character length for all name related data items to be increased to 100 characters.

# Reason for change (including benefits)

To increase the character length of all name related data items. This will ensure that schools/LAs can provide the legal name for children, ensuring that their responsibilities under GDPR are met.

# Impact of not doing the change

If the changes are not implemented, data will be inaccurate as names will be truncated and will be difficult to match data under names. By not doing the change we are at risk at not facilitating schools/LA to submit accurate information under GDPR.

# Software suppliers' summary of impact assessment

**Supplier 1**: The RFC states that all of the items are to be set to 100 characters, the fields include:

- a. Firstname, Surname These are fine
- b. Middlenames surely if we need 100 characters for firstname/surname we must need far more for middlenames?
- c. N00501 this is the Title, firstname and surname of the headteacher, 100 characters feels low for this? (it was already 70)

The RFC says "Date Required For Change": "In systems ready for March 2023" this is unreasonably short notice and there is little chance that this deadline is possible to achieve.

**Supplier 2**: We suggest that the increase in length for name should be to 60 characters.

We have been using this length of name in various countries around the world including Southern India, who are well known for very long names.

Setting the length to 60 characters will be of no inconvenience to the majority of schools in England and Wales, whereas setting it to 100 characters is likely to be significantly inconvenient.

Obviously, the case that prompted this increase in name length (44 characters) would be more than satisfied by the increase of length to 60 characters.

Please take into account that an increase to 100 characters would also disrupt CTF and Admissions transfer files for the majority of schools in England and Wales.
