Monthly Summary

- 1.1.1 This Summary Report is published in fulfilment of commitments detailed in the High Speed Rail (London-West Midlands) Environmental Minimum Requirements, Annex 1: Code of Construction Practice, for the nominated undertaker to present the results of air quality and dust monitoring undertaken in Stratford-on-Avon District (SoADC) during January 2023.
- 1.1.2 Figures 1 and 2 in Appendix A indicate the current worksites together with the dust monitoring locations for January 2023.
- 1.1.3 This summary should be read in conjunction with the overview monitoring report monthly available from <u>www.gov.uk/government/collections/monitoring-the-</u> <u>environmental-effects-of-hs2</u>, which highlights: the applicable standards and guidance, as well as the air quality and dust monitoring methodologies to be implemented by nominated undertakers throughout construction.
- 1.1.4 The current worksites as presented in Appendix A, Figures 1 and 2, include:

Long Itchington Wood North Portal site (Sublot 1A)

- 24/7 tunnel boring works;
- Operation of the Slurry Treatment Plant; and
- Operation of the Water Treatment Plant.

The Fosse Way Compound site (Sublot 2A2)

- Topsoil stripping;
- Haul roads construction; and
- Earthworks cutting (transporting material to River Leam embankment via haul road).




- Installation of drainage and culverts, excavation of ponds
- Topsoil stripping and material movement
- Further establishment of the site access road
- Bulk earthworks Southam Cutting, Windmill Hill & Ladbroke Cutting
- Embankment fill
- Earthworks and piling platform at Ladbroke Grove FAOB, Lower Radbourne FAOB.
- Piling at A423 OB.
- Piling at Ladbroke Grove FAOB.
- Earthworks and abutment works for Kineton Road Overbridge
- Kineton Road surveys
- Oxford Canal Bridge works

- 1.1.5 Five (5) dust monitors are installed at worksites, where works are underway. These sites returned a low to medium dust risk rating.
- 1.1.6 Dust monitoring location and results are presented in Appendix B, Table 1, together with line charts of monthly data from the dust monitor presented in Figure 3. All continuous dust monitoring is undertaken using indicative monitors. Despite being Environment Agency (MCERTS) certified, indicative monitors carry a higher level of uncertainty than reference monitors, and therefore cannot be strictly compared with Air Quality Standards for human health and the environment. The purpose of the monitoring undertaken is to ensure the effectiveness of the on-site mitigations.
- 1.1.7 The trigger level for PM₁₀ concentrations of 190 μg/m³, over a 1-hour period, in accordance with the updated guidance document '*Guidance on Monitoring in the Vicinity of Demolition and Construction Sites (October 2018)*' has been applied.
- 1.1.8There were no (0) dust trigger alerts recorded during the monitoring period (January
2023).
- 1.1.9 There were no (0) complaints received during this reporting period (January 2023).
- 1.1.10 Data capture was below 90% for multiple monitors due to power supply issues.

Figures 1 and 2: Worksites and Monitoring Locations within the SoADC






