Who are the Heads of Place?

Heads of Place are SCS2 Directors and are based across the UK. Our Wales Head of Place (HoP) is Glynne Jones who is also the Director of the Office of the Secretary State for Wales. Glynne is supported in his HoP role by his Strategic Advisor who is based in the locality.

The Heads of Place programme is part of the Civil Service People and Places Directorate (CSPPD) in the Cabinet Office. Its work in Wales is overseen by a Head of Place Senior Leaders Group, which has representation from across Civil Service bodies in Wales.

Each Head of Place has a Permanent Secretary Champion and the programme reports to the Locations and Property Board and the Portfolio Oversight Board.

What is the Heads of Place programme?

Through the appointment of Civil Service Directors as Heads of Place for each region and nation of the UK, we are looking to better support and respond to places by providing stronger, visible leadership of the Civil Service. Our vision is that by 2025 we will create dynamic communities of Civil Servants across departments that are reflective of each nation and region of the UK. The programme is led by our Head of Place and brings together senior leaders who work together to shape and deliver the vision of a modern Civil Service in Wales, including ensuring that we are closer to the communities that we serve and better placed to respond to local needs. To support this work, a Delivery Group is in place drawing together staff from across departments to oversee the activity underway and ensure that we are delivering our priorities.

One of the great privileges of being the UK Government's Head of Place for Wales is the opportunity it provides to meet and talk to colleagues across the Civil Service family in Wales and marvel at the superb work they do. We are creating a SCS community that will own and shape our nation's approach to realising the vision for a modern Civil Service, setting priorities and leading activity to achieve the HoP vision by focussing upon 3 strands: Places for Growth (PfG), Talent/Careers and Diversity.

- a) Places for Growth provide strategic oversight of PfG delivery by steering local delivery plans (LDPs).
- b) Talent/Careers identify priorities to strengthen talent in the Civil Service in Wales. Focus on actions that will diversify the talent pipeline into the Civil Service, support progression up through the Civil Service and promote interchange and secondments across the Civil Service and the wider public sector.
- c) Diversity and Inclusion: identify priorities for diversity and inclusion focussing on actions that address geographical exclusion and social mobility alongside protected characteristics.

Bringing together all Civil Service departments in Wales to share good practice and collaborate will be key to ensuring the success of the programme and achieving the priorities for Wales.

Opportunities to become involved are always available and I am confident that you won't be disappointed once you join us on our journey.

The types of roles available in Cardiff are:

Early Conciliation Support Officers who are the first point of contact when submitting a notification to ACAS that you intend to make a claim to the Employment Tribunal.

Conciliators who facilitate discussions around resolving disputes without the claim reaching an Employment Tribunal. Collective Conciliation who work alongside Trade Unions and/or appointed representatives to resolve large scale disputes with a view to reaching a formal agreement. Advisory Services who assist companies with large scale projects, for example restructuring. Good Practice Services who work closely with employers and stakeholders to offer expert advice, training and tailored support to help them keep up to date with best practice. Business Support who provide the administrative service to underpin the work of the wider functions of the business.

The DVLA holds more than 49 million driver records and over 40 million vehicle records. We collect around £7 Billion a year in vehicle excise duty (VED). We also maintain the registration and licensing of drivers in Great Britain, also maintain the registration and licensing of vehicles, together with the collection and enforcement of VED, in the UK. This information allows us to get the right drivers and vehicles taxed and on the road, as simply, safely and efficiently as possible.

The Driver and Vehicle Standards Agency (DVSA) is an executive agency of the Department for Transport. It employs staff throughout Great Britain, 500 of whom work at one of our Welsh offices.

Its priority is to keep everyone safe on Britain's roads.

It does this by:

- carrying out spot checks on lorries, buses, drivers and operators, and issuing over £6 million in fines pear year, while working with the police to investigate heavy vehicle collisions
- setting the driving, riding and theory tests and carrying out nearly 4 million tests each year, while regulating 40,000 driving instructors
- setting the MOT test and overseeing nearly 40 million MOTs each year, while regulating 60,000 MOT testers
- carrying out over 750,000 annual tests on lorries and buses to ensure they are safe
- overseeing around 400 vehicle safety recalls per year

We provide vehicle and driver testing and enforcement services from a network of sites throughout Wales. But we also have an office in Swansea, covering corporate support functions – including our call centre, IT and finance. We run a number of apprenticeship schemes, and enjoy partnerships with colleges throughout Wales. We're very proud that one of our apprentices is this year's Gower College Contact Centre Apprentice of the Year

The Boundary Commission for Wales (BCW) is one of four Parliamentary Boundary Commissions, covering each part of the United Kingdom, first established by the House of Commons (Redistribution of Seats) Act 1944. Each Commission is fully independent of Government, non-political and impartial and each has completed five general reviews of parliamentary constituency boundaries since it was established.

The BCW is a permanent body constituted under the Parliamentary Constituencies Act 1986 which, as amended by the Boundary Commissions Act 1992, Part 2 of the Parliamentary Voting System and Constituencies Act 2011 and the Parliamentary Constituencies Act 2020, requires all four Commissions to keep parliamentary constituencies under review by conducting a review of all the constituencies in their area every eight years (after completion of the 2023 Review).

The Chair of the Commission is the Speaker of the House of Commons, but by convention he or she does not participate in the conduct of boundary reviews or formulation of the Commission's recommendations.

The Deputy Chair therefore leads the Boundary Commission for Wales in its work. The Deputy Chair must be a serving Judge of the High Court, and is appointed by the Lord Chancellor. The Deputy Chair is supported by two Commissioners whose appointments are made by the Minister for the Cabinet Office.
