DIRECTIONS

NATIONAL HEALTH SERVICE, ENGLAND

The Alternative Provider Medical Services (Amendment) (No. 2) Directions 2023

The Secretary of State for Health and Social Care, in exercise of the powers conferred by sections 98A(3), 272(7) and (8) of the National Health Service Act 2006 (a), gives the following Directions.

Citation and commencement

1.—(1) These Directions may be cited as the Alternative Provider Medical Services (Amendment) (No. 2) Directions 2023, and come into force on 15 May 2023, immediately after the National Health Service (General Medical Services Contracts and Personal Medical Services Agreements) (Amendment) (No. 2) Regulations 2023 (**b**) come into force.

(2) These Directions are given to NHS England (c).

Amendment of the Alternative Provider Medical Services Directions 2022

- 2.—(1) The Alternative Provider Medical Services Directions 2022 (d) are amended as follows.
- (2) In direction 7AA (disclosure of information about NHS earnings: jobholders)—
 - (a) in paragraph (10), for the words from "to include the term" to the end of that paragraph substitute—

- (a) to include the term specified in paragraph (6) in any contract of engagement which T enters into with a jobholder on or after entering into the contract with the APMS contractor;
- (b) to use reasonable endeavours to include that term in any contract of engagement which T has entered into prior to entering into the contract with the APMS contractor.".
- (b) in paragraph (11)—
 - (i) in sub-paragraph (a), for the words from "to include the term" to the end substitute—
 - (i) to include the term specified in paragraph (6) in any contract of engagement which T enters into with a jobholder on or after entering into the contract with S;

- (ii) to use reasonable endeavours to include that term in any contract of engagement which T has entered into prior to entering into the contract with S;":
- (ii) in sub-paragraph (b), after "requiring P to" insert "use reasonable endeavours to";
- (c) for paragraph (12) substitute—
 - "(12) The term is one which requires T—
 - (a) to include the term specified in paragraph (6) in any contract of engagement which T enters into with a jobholder on or after entering into the contract with P:
 - (b) to use reasonable endeavours to include that term in any contract of engagement which T has entered into prior to entering into the contract with P.".
- (3) In direction 14 (mandatory terms of an APMS contract under which essential services are to be provided), in paragraph (1)—
 - (a) after sub-paragraph (gc) insert—
 - "(gca) regulation 64B (patient access: other availability of directly bookable appointments);";
 - (b) after sub-paragraph (i) insert—
 - "(ia) Schedule 2, paragraph 3A (new telephone contract or arrangements);";
 - (c) for sub-paragraph (j) substitute—
 - "(j) Schedule 2, paragraph 5 (contact with the practice);".
