# What is a Minor Report?

Some prisons or YOI's use a system known as 'minor reports' for prisoners charged with less serious offences. The charges that may be dealt with in this way are listed below. The case may be heard by a senior officer rather than a governor or director, who may impose a limited range of punishments but otherwise minor reports are similar to normal adjuications.

If you are serving a sentence you will be charged under **Young Offender Institution Rule 55** for the following offences:

### paragraph 6

'intentionally endangers the health or personal safety of others'

#### paragraph 7

'intentionally obstructs an officer in the execution of his duty'

#### paragraph 18

'destroys or damages any part of a YOI'

#### paragraph 20

'absents himself from any place he is required to be'

#### paragraph 21

'is disrespectful to any officer'

'Uses threatening abusive or insulting words or behaviour'

# paragraph 24

'intentionally fails to work properly'
