### PROVISION OF REQUESTED INFORMATION

Thank you for your request for information about imported plants, which the Animal and Plant Health Agency (APHA) received on 09 December 2022. Your request has been handled under the Environmental Information Regulations (EIR's) 2004.

The information you requested and the response is detailed below:

"Xanthomonas arboricola pv. pruni

I would be very grateful, if you could provide me with data on:

- 1. The number of positive interceptions of the above pathogen on imported material and where it came from.
- 2. The number of detections on UK premises since the first time (in 2014)

I expected that this info would be collated somewhere and publicly available - but I can only find isolated snippets like here:

An interception is a finding of infected plants where those plants can be attributed with certainty as having being been sourced from outside England & Wales.

#### Note 2:

Outbreaks on premises are those findings where the infected consignment has been on the premises for a period of time so as not be able to attribute with certainty the initial source of infection.
