

Introduction

1.1 This addendum summarises the responses received to the Freedom of Information (FoI) request submitted to Uttlesford District Council (UDC) on 30 March 2023 and returned on 28 April 2023 (see Appendix 1). It should be read in conjunction with sections 5 and 6 of Marrons 'Stansted Mountfitchet Local Housing Need Assessment' (April 2023) and emphasises the need for affordable housing across Uttlesford District but also locally in Stansted Mountfitchet.

Fol Responses

1.2 The key points to note from the Fol response are as follows:

Uttlesford District

- The Fol confirms our main report's conclusion that 1,272 households were on the Council's Housing Register as of 31 March 2022;
- The Fol has added to our main report by confirming the number of households in temporary accommodation has doubled from 17 households to 38 households in 12 months;
- The Fol has also provided new information in respect of homelessness, confirming there to have been a total of 179 homelessness applications in Uttlesford District between 01 April 2022 and 31 March 2023 (62 applications for a prevention duty and 117 a relief duty);
- In terms of the number of affordable homes lost to the 'Right-to-Buy' scheme,
 the Fol states 112 properties to have been lost between 2011/12 and 2021/22.
 This represents an increase from the information we had collated and
 presented in Table 5.2 of our main report and means the net affordable
 delivery was in fact lower than we had originally calculated;
- The Fol directs us to Government live tables in terms of overall housing completions and affordable housing completions, thereby validating the approach presented in our main report.

Stansted Mountfitchet

- The village of Stansted Mountfitchet is traversed by two electoral wards (Stansted North, and Stansted South & Birchanger), hence the inclusion of Birchanger in some of the data;
- The Fol provides new information in respect of the demand for affordable housing in Stansted Mountfitchet, stating there to be 375 households on the
- Uttlesford District waiting list who have identified the village as their preferred choice of location. The Fol confirms a further 146 households as identifying



Birchanger as their preferred choice of location (521 households in total across the two wards which traverse the village);

- In comparison the FoI states the social housing stock to be 87 in Stansted North ward, and 187 in Stansted South & Birchanger (274 in total);
- Demand for affordable housing in Stansted Mountfitchet and Birchanger therefore clearly outstrips demand;
- This demand is emphasised by the FoI stating how only 11 social housing dwellings were let in the 12 months to March 2022 across the Stansted Mountfitchet and Birchanger area despite the significant numbers on the waiting list whose preferred location is the same area;
- The Fol has also provided the average waiting times for affordable housing across the District based on bedroom size. This data is set out in Table 1 and reveals significant waiting times for smaller affordable properties.

Summary

- 1.3 The Fol has validated data set out in Marrons main report, but has also provided further data which evidences the clear affordable housing need locally across the two electoral wards which traverse Stansted Mountfitchet, and across Uttlesford District.
- 1.4 The increase in households in temporary accommodation across the District over the most recent 12-month period, plus the number of homelessness applications emphasises the worsening affordability across the District.
- 1.5 Luxus Homes proposal includes four 1-bed, eight 2-bed, and four 3-bed affordable properties. As Table 1 shows the waiting time for 1-bed is nearly 2 years, and for 2-bed is nearly a year. The wait for 3-bed is over 6 months. Luxus Homes proposal provides the size of properties most in need according to the data provided by the Council themselves through the Fol.
