

PROVISION OF REQUESTED INFORMATION

Thank you for your request for information about the number of commercial laying flocks, which the Animal and Plant Health Agency (APHA) received on 9 January 2023. Your request has been handled under the Freedom of Information Act (FOIA) 2000.

The information you requested and the response is detailed below:

"I am looking for the following information for UK commercial laying flocks (do not require data to include backyard flocks). Please could you advise if this data is available and where to access?

Required by county if possible:

- Number of units
- Number of birds"

The information requested can be found at Appendix 1. The information provided is current at the time of this response.

APHA register keepers of animals and poultry for disease control purposes. The information we do hold is the average stock numbers passed to the APHA when a premises is initially registered or when the record is updated.

Where the county is described as blank the county of the premises was not recorded at the time of registration and APHA have not been informed since by the owner/keeper.

Information disclosed in response to this FOI request is releasable to the public. In keeping with the spirit and effect of the FOI and the government's Transparency Agenda, this letter and the information disclosed to you may be placed on GOV.UK, together with
