Strategy:

• The Leaf MAT will formalise the collaboration and build on the successful networks already established by the schools ensuring those involved are part of a robust and agile organisation. It was acknowledged that further due diligence is needed, and the Regions Group will work closely with the senior leadership of the Trust as it develops its vision, values, and central capacity.

Governance and leadership:

• The experience of the senior leadership team was discussed, and it was acknowledged that leading a large trust from the point of establishment will be a challenge. Trustees will work with senior leaders to ensure they address areas for development in their new roles.

Points raised in discussion:

Strategy:

- The growth plans of the merged trust was discussed, future growth would be subject to regular updates with the trust and the Regions Group team.
- The opportunity to rebrand the new organisation proposed name Blackdown Education Partnership was positively acknowledged as indicating the collaborative working of both trusts to create a new entity with its own culture, vision, and ethos.

Service Improvement:

• The SI model of the merged trust was discussed. UAT and TCPT have a wellestablished relationship having worked together on several strands of school improvement work. The trusts are actively developing the SI strategy and curriculum for Blackdown Education Partnership. Both trusts recognise that there is more that they need to do, and this will be subject to regular updates with the trust and the Regions Group team. There is ongoing discussion about commissioning external support to help shape the SI strategy.

Finance:

• Both trusts currently have good track records of financial management and delivering balanced budgets.

Project: Whether to approve The Sky Academy, **Somerset** transferring from Learn@ MAT to Cabot Learning Federation (CLF).

Points raised in discussion:

Strategy:

• Cabot Learning Federation's strategy for growth includes expanding into the special and AP sector and are considered a strong option in terms of capacity in SEMH to drive forward rapid improvement. The growth strategy of CLF will be subject to regular updates with the trust and the Regions Group team. The need for other Trusts both existing and new in the Somerset region with the expertise and capacity to be able to support intervention was acknowledged.

Finance:

 The school's financial position represents a risk for the Trust if they are not able to negotiate higher top-up funding levels. Assurances were provided by the Education and Skills Funding Agency (ESFA) and Regions Group that they will undertake a full review with continuing support through regular updates with the Academy and the Trust.

• TSAT operate 21 schools across five geographical hubs and are considered as a strong option to address key areas specific to the Bay Education Trust schools. Regions Group team will maintain regular engagement with TSAT on their future growth plans.

• TSAT and Bay have both been pro-active in agreeing a Memorandum of Understanding. Regular steering groups are in progress comprised of leaders from both trusts, working towards a clear due diligence process and shared culture, vision, and ethos.
