Introduction/Background

This research aimed to explore consumer behaviour relating to upholstered garden furniture and baby travel products, in support of a review of the Furniture and Furnishings (Fire) (Safety) Regulations 1988. The research had a particular focus on investigating where upholstered garden furniture is used and stored and the use of baby travel products in the home. The results of the research will supplement the evidence base which will inform the new approach to furniture fire safety.

Methodology

In March 2021, OPSS commissioned YouGov to conduct an online survey to inform the review of the Regulations. YouGov included 8 questions (see Annex A), drafted by the Office for Product Safety and Standards (OPSS), in their omnibus survey which is regularly distributed online to a nationally representative sample of approximately 2,000 GB adults. Following quality assurance checks conducted by YouGov's internal research team, the questions were included in the omnibus survey over two waves resulting in an overall sample of 4,435 adults.

The research questions included in the omnibus survey consisted of 8 closed questions covering whether respondents owned upholstered outdoor furniture, where such furniture is used and stored, the likelihood respondents would buy upholstered outdoor furniture for use inside the home and behaviours relating to baby travel products. Images of example upholstered outdoor furniture were included in the survey to assist with respondent interpretation of the questions. OPSS also requested for additional demographic questions to be included in the omnibus covering ethnicity, religion, sexual orientation and disability.

Summary of Findings¹

Behaviours relating to use of outdoor upholstered furniture

Of the total 4,435 sample, 29% of respondents owned outdoor upholstered furniture. When these respondents were asked where they stored this furniture when not in use, just under a quarter (24%) indicated inside the home whilst the majority reported storing outdoor upholstered furniture outside (65%).²




Graph A: Comparison of results from question CBF_Q2

Of those same respondents who own outdoor upholstered furniture, more than half owned a barbecue (63%) and a quarter (25%) owned an outdoor firepit. Nearly three quarters (74%) of respondents who owned a barbecue reported positioning their upholstered furniture two or more metres away from the barbecue when it is in use. A smaller proportion (56%) of the respondents who owned an outdoor firepit reported positioning their upholstered furniture at this same distance when their firepit is in use.

Based on the total sample of 4435 respondents, 14% reported that they currently use outdoor upholstered furniture inside their home and 13% reported that they would be likely to buy outdoor furniture for indoor use in the future. Further analysis exploring differences between key demographic groups was undertaken.

Whilst there are no statistically significant differences between males and females and their current use of outdoor furniture indoors, a higher number of females than males reported being likely to buy outdoor furniture for indoor use in the future (15% of females vs. 10% of males). Age was also seen to be a factor which impacted indoor use of outdoor furniture, with younger respondents being more likely to both currently use outdoor furniture indoors and consider buying outdoor furniture for indoor use in the future. For example, 19% of 18-24 year olds report currently using outdoor furniture indoors compared to 12% of respondents aged 55+. Furthermore, BAME respondents were statistically significantly more likely than white respondents to currently use outdoor furniture indoors (22% vs. 14%) and be more likely to buy outdoor furniture for indoor use in the future (25% vs. 12%).

Statistically significant differences can also be seen between respondents from different regions with those from London (18%) being more likely than those from the North (11%), Midlands (12%) and East (13%) to currently use outdoor furniture indoors. Respondents from the South (17%) were also statistically significantly more likely than those from the North and the Midlands but the difference between the South and London is not statistically significant. The differences between the North, Midlands and East are also not statistically significant with the exception of those from the East reporting being more likely than those from the North to buy outdoor furniture for indoor use in the future (15% vs. 11%).


Respondents who had any number of children in the household were statistically significantly more likely than those with no children in the household to both currently use outdoor furniture for indoor use (17% vs. 13%) and report a higher likelihood of buying outdoor furniture for indoor use in the future (15% vs. 12%). In addition to this, those from ABC1 social grades were statistically significantly more likely than those from C2DE social grades to currently use outdoor furniture indoors (16% vs. 12%). There were no statistically significant differences between social grades when considering likelihood of future purchases of outdoor furniture for indoor use.



It is important to note that in each of the specific cases presented above, a greater proportion of respondents reported not currently using outdoor furniture indoors and not being likely to buy outdoor furniture for use indoors in the future.

Behaviours relating to use of baby travel products

Based on the sample of respondents who were parents³, 18% reported that they had never stored prams inside their home. For those who had stored prams inside their home, 38% had done so in the corridor, 15% in the living room and 32% in another place inside the home. 15% reported storing prams in their garage⁴.

When considering where they had ever stored carry cots and car seats, 32% of parents reported never storing carry cots inside their home and 38% reported never storing car seats inside their home. Of those who had stored either product in their home, 13% report storing carry cots in the corridor and 17% report storing car seats in the corridor. 20% and 12% of parents report storing carry cots and car seats in the living room respectively and for any other place inside the home, 36% of parents had stored carry cots and 24% had stored car seats. Furthermore, 8% reported storing carry cots in their garage⁵ whilst 18% reported storing car seats in their garage⁶.

When asked if they had ever brought the travel products into their home to allow their child(ren) to continue sleeping in the product, 54% of parents said they had done so with prams whilst a lesser number of 38% brought in carry cots and 35% car seats.
