Project: JFK Special School (part of Learning in Harmony MAT), Newham - increasing capacity from 60 to 100

AB discussion: JFK Special School opened in 2014. It is part of the Learning in Harmony MAT, a trust comprising of ten schools, the other nine of which are Primary schools in Newham (5), Islington (1) and Southend (4). JFK operates through four school sites at Stratford, Plaistow, North Woolwich and Beckton. It offers all-through provision for pupils aged 4-19 and has current capacity for 163 pupils.

The proposed expansion relates to the Beckton site which currently caters for students aged 11-19 with Profound and Multiple Learning Difficulties (PMLD) and Autistic Spectrum Condition (ASC).

Board members felt this was a sound application and supported the proposal.

Project: Oaklands Primary Academy (SAT), Bromley – to join Chancery Education Trust

AB discussion: Oaklands Primary Academy is a 3 form entry single academy trust with 475 pupils in 7 year groups.

Chancery Education Trust (CET) established in 2015 is a MAT consisting of three schools: Darrick Wood Infant and Nursery School, John Wood School & Nursery, and Pickhurst Academy.

Transferring to CET will allow Oaklands to benefit from CET's financial stability and governance structure.

The Board discussed CET's growth plan and capacity to take on new schools.
