Thank you for your email of 17 March 2023 to the Ministry of Defence (MOD), requesting the following information:

"Can I request a copies of all policies that allow medical advisors to try an change wielding on reports to weaken a Veterans statement of case and where it allows them to use seeing a gp or going to hospital or seeing family as a reason to try and weaken a claim and where this is also in policy documents.

I also require and foi done to show how many veterans competing at very high fitness and training levels at invictus and warrior games have had war disablement pension claims or AFCs claims re investigated for doing sports and also social engagement and also able to travel across the world."

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

A search for the information has now been completed within the MOD and I can confirm that no information in scope of your request is held.

Under Section 16 of the FOIA (Advice and Assistance) you may wish to know that no policies have been constructed to impair or invalidate an Armed Forces Compensation Scheme (AFCS) claim.
