

# Local authority response notice to an appeal against a decision in relation to service permits

## **About this form**

This form is to be used by a local authority to provide their response to an appeal made by an operator under section 123T of the Transport Act 2000 ("2000 Act") against the decision of the local authority to:

- refuse an application for a service permit under section 123Q of the 2000 Act;
- attach condition(s) to a service permit when it is granted under section 123R of the 2000 Act;
- attach condition(s) to an existing service permit under section 123R of the 2000 Act:
- revoke or suspend a service permit under section 123S of the 2000 Act.

The completed form should be sent to the traffic commissioner so that it is received within 28 days from the date the traffic commissioner sent the notice of appeal to the local authority.

This form should be used to respond to an appeal against a decision under a franchising scheme, if you are responding to an appeal that relates to a decision under an enhanced partnership scheme you should use form EPS002 available here:
