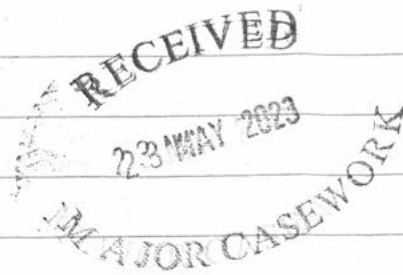

AS PREVIOUSLY STATED IN REPLY TO PREVIOUS APPLICATIONS :-

- (1) THE BULLDOZER TURNED UP IN THE LATE AFTERNOON BEFORE A BANK HOLIDAY AND PROCEEDED TO TRASH THE SITE, WHICH HAD BEEN SCRUB WOODLAND, WHICH WAS SLOWLY TURNING TO A WOOD WITH 25-40 YEAR OLD OAK TREES AND HAZEL TREES (AN OAK WOODLAND)
- (2) THE SITE WAS A HAVEN FOR WILDLIFE INCLUDING DOORMICE (NOT NOW) AS WELL AS DEER AND A RANGE OF OTHER ANIMALS INCLUDING GRASS SNAKES AND SLOW WORMS!
- (3) THE SITE HAD A WIDE RANGE OF WILD FLOWERS, INCLUDING PYRAMIDAL ORCHID, BLUE ORCHID, COMMON SPOTTED ORCHID, YELLOW WORT, COMMON CENTAURY AND THE VERY RARE RED-HEMP NETTLE. (NOT NOW)
- (4) THE POND ON THE SITE WAS FILLED IN (IT KEEPS RE-APPEARING)
- (5) THE SITE IS TOTALLY UNSUITABLE FOR THE APPLICATION :-
  - (A) THE STREAM THAT RUNS ALONG THE BOTTOM OF SITE IS A TRIBUTARY OF THE RIVER STORT. WATER RUN OFF FROM A SITE THIS LARGE, COVERED IN CONCRETE OR TARMACADAM, WOULD BECAUSE OF THE ANGLE OF THE SLOPE CARRY POLLUTANTS INTO THE RIVER.
  - (B) ACCESS TO THE NEARBY M11 ROUNDABOUT WOULD CAUSE EVEN MORE TRAFFIC CONGESTION.
  - (C) THIS WOODLAND WAS A BUFFER ZONE BETWEEN OUR VILLAGE

AND THE MOTORWAY ROUNDABOUT, CUTTING OUT NOISE AND POLLUTION.

(D) NEARBY HOUSES WOULD GET NOISE POLLUTION 24 HOURS A DAY AND LIGHT POLLUTION ALL NIGHT. THIS WOULD BE TOTALLY UNACCEPTABLE!
