The local area has seen much development with extra houses and traffic. Every piece of spare land in Takeley seems to being built on. I was appalled when Wren kitchens brought this land and then cleared it land without proper consultation with the correct local authorities. This was all reported on face book, local newspapers and social media for days and I personally know some of the local residents, they have seen their local area of beauty ruined. I cannot see how this will not flood the gardens that run adjacent to this planned depot once it has been cleared and build on. What with problems crossing the M11, traffic and noise it seems a crazy idea to me and totally inappropriate for the area that this proposal is made.
