Thank you for your email of 3 May 2023 to the Ministry of Defence (MOD) requesting the following information:

"I am requesting information on the medal entitlement for Horace Durdin 1639847 RAF.

The medal entitlement of a WW2 RAF serviceman who service in WW2, details of campaign medals and/or post war medals he is entitled to and if claimed prior to his death.

One of the post war medals that may be of relevance is if his service with AOSEA [Air Operations South East Asia] from after the end of WW2 makes him entitled to the general service medal [GSM] with the clasp "South east asia 1945-1946". I am also requesting if this was claimed prior to his death.

If medals were issued, i am requesting you send a copy of the medal index card(s) for these [digitally via scan/photo]."

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

A search for the information has now been completed within the Ministry of Defence and I can confirm that all the information in scope of your request is held.

Based on the Service Record provided, Mr Durdin's medal entitlement is as follows:

- 1939-45 Star
- France and Germany Star
- War Medal

These were issued via fanfold 50289 on 20 June 1950, therefore we cannot provide a copy of a medal card. Fanfolds were issue voucher books used by the RAF to record the issue of WW2 medals instead of using individual medal cards.

With regards to the General Service Medal (GSM18), Mr Durdin is not eligible for this award. Although he was deployed with Air Command South-East Asia (ACSEA) he was not serving with a qualifying unit in Java and Sumatra, which is the requirement for the medal.
