You can apply for a minimum of £10,000 and a maximum of £100,000 for projects supporting the recreational fishing sector that develop infrastructure & promote sustainable growth.

#### Lyme Bay consultation closed

The Fisheries Management team in the MMO visited multiple ports over the course of the 12 weeks of the Lyme Bay consultation and helped gather responses.

The consultation has now closed with over 200 responses received by the MMO, both online and through paper copies. We have now begun the process of analysing these responses to identify the next steps, and a workshop to discuss the result of the consultation and potential next steps is being held on the 19th June.
